

## United Way Fox Cities Sweepstakes Incentive Rules for 2018 Chevy Trax

1. This incentive promotion begins on April 1, 2018 and ends at 4:30 p.m. Central Time on December 7, 2018. Participants must be legal residents of Wisconsin, at least 18 years of age, have provided a current phone number, and possess a valid Wisconsin driver's license.
2. The winner will receive a 2018 Chevy Trax donated to the Sponsor by Bergstrom Automotive. As a bonus, the car will also include a kayak. Odds of winning depend on number of eligible entries received.
3. Any United Way Fox Cities donor that timely gives a new, undesignated gift of \$52 (\$1.00 per week), or a previous year donor who timely gives an undesignated minimum gift of \$52 that has increased by at least \$1 from the previous year, qualifies for one entry in the 2018 Chevy Trax. Entry without donation can also be made by sending a letter with proper postage to United Way Fox Cities, Attn: Drawing, 1455 Midway Road, Menasha, WI 54952, containing name, age, address and phone number. 4. The Pledge Form or Entry Letter must be returned to the Sponsor by 4:30 p.m. Central Time on December 7, 2018. Sponsor will not be responsible for companies that fail to submit their employees' pledge forms or any other lost submissions by this date.

The potential winner is required to provide contact information, proper photo identification, valid driver's license and verification of compliance with these Rules upon presentation of prize. If the potential winner does not meet these eligibility requirements or is not in compliance with these Official Rules, the potential winner will be disqualified and an alternate winner will be selected.

Entrants agree to hold harmless Sponsor, Bergstrom Automotive and their parents, subsidiaries, affiliates, agencies, officers, directors and employees from responsibility for damages, losses or injuries, including death, personal injury or property damage due in whole or part, directly or indirectly, from participation in this promotion or acceptance, possession, use or misuse of the prize.

### **Ensuring the Integrity of the Chevy Trax Car Drawing Entries**

Those individuals that qualify for the Chevy Trax and kayak are automatically and systematically (not manually) entered into the drawing as their pledges are processed. Participating public sector campaigns do provide individual donor information, which is audited, so public sector qualifiers can be assured they will be included and there is little room for human error. Companies, who do not typically provide individual pledge information, may submit a list of those employees who have qualified. Those names are added to the data base of automatic qualifiers. Additionally, those people who submitted an entry outside of the automatic qualification process are also entered into the data base.

Two separate pulls of those who qualify are conducted by the VP Finance & Administration, and the Senior Accountant, for Sponsor, and compared to ensure everyone's inclusion prior to the drawing. The final list of names is then scrambled by the computer so they are not in alphabetical order and each name is assigned a random number. A person not employed with

Sponsor chooses a number from the total assigned field of numbers and the winner of the drawing is the person blindly assigned by the computer to that number.

Although Sponsor cannot publish the list of all those who qualify, if an Employee Campaign Manager requests a list of their company qualifiers, Sponsor can provide it prior to the drawing, but after all pledges received by December 7, 2018 have been posted.
