United Way Fox Cities Official Rules for 2022 Hyundai Santa Cruz Sweepstakes

Sponsored by United Way Fox Cities (the “Sponsor”), 1455 Midway Road, Menasha, WI 54952. NO DONATION NECESSARY. VOID WHERE PROHIBITED. DONATION WILL NOT IMPROVE CHANCES OF WINNING.

1. This incentive promotion begins on April 1, 2022 and ends at 4:30 p.m. Central Time on December 9, 2022. Entrants must be legal residents of Wisconsin, at least 18 years of age, possess a valid Wisconsin driver’s license at time of entry.
2. The winner will receive a 2022 Hyundai Santa Cruz from United Way Fox Cities. Odds of winning depend on number of eligible entries received.
3. Any United Way Fox Cities donor that timely gives a new, undesignated gift of \$52 (\$1.00 per week), or a previous year donor who timely gives an undesignated minimum gift of \$53 that has increased by at least \$1 from the previous year, is eligible to qualify for one entry in the 2022 Hyundai Santa Cruz sweepstakes.
